

# Players Club Agreement - Bronze Level

The Players Club Pass entitles the active passholder and only the active passholder to the following benefits:

- Unlimited range balls at all Magnolia Golf Properties
- 1 round of golf per month that can be used at all Magnolia Golf Properties
- 7 day booking window for tee time reservations
- 20% off all soft goods (not eligible on sale items)
- 10% off all hard goods (some manufacturers not eligible)

The Players Club Pass shall be issued in the name of the passholder. Passholder acknowledges that children under the age of 16 must be signed into the Club by a parent or guardian, and children under 11 years of age must be accompanied by a parent or guardian while at the Club. The term of this Month-to-Month Players Club Agreement (this "Agreement") is monthly and shall commence on the date this agreement is executed and payment of the first monthly Plan Fee is received by the club. Either Party may terminate this agreement by giving thirty (30) days advance written notice of termination. Passholder is responsible for all fees incurred during the thirty - day (30) notice period, regardless of which party elects to terminate. The Club may modify the monthly Plan Fee and benefits upon a least a thirty (30) day advance written notice to the passholder. Passholder Initials: (\_\_\_\_\_)

Passholder agrees to maintain a current credit card account in Passholder's name on file with the Club at all times. In the event that Passholder's account is more than thirty (30) days past due, Club has the right to bill such past due amounts to Passholder's credit card. Passholder agrees to immediately notify the Club of any changes in credit card information and understands those changes must be done through the Pro Shop Staff. Do NOT reply to billing notifications! Passholder further agrees that the Club is not responsible for any fees incurred as a result of the Club billing Passholder's credit card (e.g., for overdrawn accounts, exceeding credit card limits, etc.) Passholder Initials: (\_\_\_\_\_)

While you are active in the program, the rounds of golf that are included in this plan will carry over for three months and may not be used past the 90th day. If you elect to cancel or fail to pay for this plan the carried over rounds are terminated. Rounds and discounts are only for the registered active Passholder and cannot be saved.
